URGENT ALERT: THIS INFORMATION REQUEST CONTAINS DIRECT EVIDENCE OF THREATS OF VIOLENCE AND OTHER HIGH CRIMES AND MISDEMEANORS STILL BEING COMMITTED IN PLAIN VIEW AGAINST TWO AMERICAN CITIZENS IN NAPLES FLORIDA BY SENIOR U.S. GOVERNMENT OFFICIALS AT THE DEPARTMENT OF HOMELAND SECURITY AND THE NATIONAL LABOR RELATIONS BOARD. THE PURPOSE OF THIS REQUEST IS THREEFOLD: (a) TO HELP PROTECT KNOWN EVIDENCE HELD BY THE GOVERNMENT; (b) TO CREATE A PUBLIC RECORD IN ORDER TO PRESERVE THE INFORMATION REQUESTED FOR FUTURE USE IN THE EVENT THE COUPLE IS KILLED BY THE U.S. GOVERNMENT; AND (c) TO PROTECT THE TWO FLORIDA BUSINESS OWNERS AND THEIR FAMILIES AND PROPERTY FROM ANOTHER SURPRISE ILLEGAL ATTACK THAT THEY FEAR COULD RESULT IN DEATH. ALL THE CRIMINALS INVOLVED REMAIN EMPLOYED BY THE U.S. GOVERNMENT AND PAID BY TAXPAYERS DESPITE THE CREDIBLE WRITTEN DEATH THREAT COMPLAINTS THAT WERE REPORTED TO THE FBI AND CONGRESS AND THE DHS & NLRB INSPECTOR GENERAL IN EARLY OCTOBER 2019. (see FOIA response number NLRB-OIG-2020-000166 dated December 13, 2019, for documentary evidence and proof that all the individuals named in the DEATH THREAT complaints are still employed by the government and no action has been taken to protect the NAPLES FLORIDA couple from being killed by CURRENT employees of the federal government who have threatened their lives AND TAKEN AFFIRMATIVE STEPS USING DHS AGENTS TO CARRY OUT THEIR THREATS IN RETALIATION FOR REPORTING THEIR CRIMES TO CONGRESS AND THE FBI.)

ALL RECEIPIENTS OF THIS ‘REQUEST FOR INFORMATION’ ARE ADVISED TO CONTACT LAW ENFORCEMENT OFFICIALS IMMEDIATELY UPON READING THIS ‘REQUEST FOR INFORMATION’ TO REPORT THAT YOU HAVE RECEIVED FACTUAL EVIDENCE ABOUT A THREAT OF VIOLENCE MADE AGAINST TWO AMERICAN CITIZENS IN NAPLES FLORIDA BY SENIOR U.S. GOVERNMENT OFFICIALS WHO STILL REMAIN CAPABLE OF KILLING THE COUPLE USING TAXPAYER FUNDED RESOURCES RIGHT NOW.

BACKGROUND: In early October 2019, National Labor Relations Board Chairman John F. Ring issued two written threats of violence against two American Citizens and their small media company in Naples, Florida. After the death threats from NLRB Chairman John F. Ring were reported to Congress and the FBI; on October 7, 2019, a Petition to the Government for a Redress of Grievances was officially delivered to all branches of the federal government CONTAINING THE DEATH THREAT COMPLAINTS. Five weeks later and after NLRB Chairman John F. Ring (a) ordered death threats and (b) was notified about the complaint filed with the FBI and Congress and DHS and NLRB Inspector Generals against him AND (c) was informed about the Petition to the Government for a Redress of Grievances which is protected under the First Amendment to the U.S. Constitution and was sent to all branches of the federal government; NLRB Chairman John F. Ring again abused his authority and committed malfeasance by ordering a second surprise attack on the journalist and the pet artist and their company in Naples, Florida. His conduct constitutes high crimes and misdemeanors by an executive branch appointee and the evidence will prove a nexus between his criminal acts and all the articles provided in the links contained in this request.

Chairman John F. Ring denied the couple and their company all their rights under the law and threatened their lives. The couple had posted on social media after the death threats in early October that they were hiding awaiting action by the FBI, and stated clearly online and to all their friends that they feared an attack by the government. The evidence proving a nexus between Chairman Ring's death threats against the couple, the attacks by DHS agents on two occasions in two years and the publication by the Capitol Hellway Media Company LLC of widespread abuse of power, corruption and malfeasance at the NLRB will be proven beyond a reasonable doubt. The level of malfeasance that can be proven by senior government officials at the NLRB and DHS is characteristic of a tyrannical government in a dictatorship form of government that openly violates the rule of law and citizen rights. The case for high crimes and misdemeanors against the NLRB Chairman John F. At 12:00 pm EST on November 8, 2019, Acting Secretary of Homeland Security Kevin McAleenan and National Labor Relations Board Chairman John F. Ring & General Counsel Peter B. Robb ordered two DHS-FPS agents to execute a surprise attack on a journalist and the pet artist at their home business in Naples Florida on the Veteran's Day holiday weekend with the expressed stated purpose on video to violate their constitutional rights. The journalist is

a retired U.S. Marine Corps veteran and former federal government whistleblower who was retaliated against by the NLRB for reporting corruption to NLRB Board Member **Lauren McFerran** in an email dated November 30, 2016.

All of the below listed constitutional protections were breached ON DECEMBER 6, 2017 & NOVEMBER 8, 2019 BY THE NATIONAL LABOR RELATIONS BOARD AND SECRETARY OF HOMELAND SECURITY.

In addition, written threats of violence were issued against the journalist, pet artist and their company.

The DHS agents on November 8, 2019, stated that they were sent to interrogate the couple by specific NLRB attorneys who should be disbarred. The agents falsely accused the couple of committing crimes repeatedly which threatened the couple with harm if they published the textbook in 2020. The DHS agents knew they were being filmed and still arrogantly confirmed on video multiple times that the interrogation was directed by the NLRB; that it was an intentional violation of constitutional rights, and that they could care less about any complaint we filed against them because they are protected. The two agents openly violated the law – were told repeatedly that they were violating the law on behalf of DHS and the NLRB by the couple on video, and still could care less about it. Prediction: If you don't fire them now, they will be fired after the documentary comes out next year and everyone who reads this request for information and doesn't notify law enforcement should probably be fired too.

According to a public announcement by the company with possession of the video recorded at the time of the attack, it will be aired in a documentary in the Fall of 2020, with the release of the textbook about corruption in the federal government that the federal agents hoped to stop. The entire textbook was developed online using crowdsourcing, and the NLRB and DHS have been surveilling the publication with the intent to harm the journalist since he left the agency in 2017. The company has strictly adhered to the Bill of Rights and all laws, and the DHS and NLRB have acted with malicious intent to deny the company and its two employees their freedoms guaranteed by the U.S. Constitution.

The address of the November 8, 2019, attack by DHS agents was inside a private security & gated community at [REDACTED]. According to private investigators and others working on the case for the company, the security firm employed to protect the community has confirmed that both federal agents illegally entered the gated community without any permission or advance notice. The police have also been informed and advised the couple of there rights to protect themselves. The DHS agents stated purpose on video inside the community that they entered illegally was to violate the constitutional rights of the couple in retaliation for blowing

the whistle on corruption at the National Labor Relations Board (NLRB) and other federal agencies including the Department of Homeland Security, Department of Defense and the Department of Labor. The journalist is a whistleblower and former federal employee. The agents stated purpose on video was that they were acting on direct orders from NLRB attorney Elizabeth Bach who works for Chairman Ring.

REQUEST #1 of 2: This request is for all documentation, investigations, electronic records, transcripts, phone conversations, and any other material evidence related to the attack made by the Secretary of Homeland Security and the Chairman of the National Labor Relations Board on November 8, 2019 at the address of John & Cathy Edwards in Naples Florida. ([REDACTED])

REQUEST #2 of 2: This second request is for DHS Case Number N17003708, a related occurrence. This request is for all documentation, investigations, electronic records, transcripts, phone conversations, and any other material evidence related to the attack made by the Secretary of Homeland Security and the Collier County Florida Sheriff's Department and NLRB on December 6, 2017, at the address of John & Cathy Edwards in Naples Florida ([REDACTED] - a private security & gated community). On December 6, 2017, the DHS committed the exact same violation of the law against this couple and their company at a prior address for the same reason in the same gated community. For that attack, the assailants used a Collier County Sheriff's office counterintelligence officer to covertly gain entry to the community and allow for a surprise attack 6 calendar days after the journalist published this article.
